From Tucson to Los Angeles will be on the Sunset Limited and the Los Angeles to Albuquerque portion will be on the Southwest Chief. We will board passengers at any Amtrak station stop. All passengers must be AAPRCO members or a guest of an APPRCO member and will need to be registered for the convention. Only one guest per membership is allowed. The special train will operate on non-Amtrak routes and is expected to travel via Trinidad, Walsenburg, La Veta, Alamosa, Pueblo, La Junta, Amarillo, Clovis and Belen before returning to Albuquerque now has the Rail Runner commuter rail service to Santa Fe making this a viable day trip.
